RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING NOVEMBER 10TH, 2011

The Medina Township Board of Trustees met in regular session at the Medina Township Hall on November 10th, 2011, to conduct the business of the Township. Vice-President Gardner called the meeting to order at 7:06 pm with the following Trustees in attendance: Sarah (Sally) Gardner and Ray Jarrett. Also in attendance was Linda DeHoff Fiscal Officer, David Arbogast Police Chief, Shawn Kasson Asst. Fire Chief, Denny Miller Road Foreman, Jeff Kessler Sports Field Manager and the general public.

Roll Call

Mrs. Gardner asked for a roll call of all members present. Trustees present were Mrs. Gardner and Mr. Jarrett. Mr. Todd arrived at the meeting at 8:32 pm.

Pledge of Allegiance

Mrs. Gardner led the Pledge of Allegiance.

Moment of Silence

Mrs. Gardner asked for a moment of silence for our military personnel at home and overseas

Mark Herwick - Homestead Insurance - Health Insurance

Mark Herwick of Homestead Insurance discussed the changes to the Health Insurance for 2012 and asked Trustees for permission to go out for bids to find lower rates for the same coverage with an effective date of January 1, 2012. Trustees agreed.

Approval of Accounts Payable

Mrs. Gardner motioned to approve warrant #22447 to #22498 total amount of \$66,471.97. Mr. Jarrett seconded the motion. Voting aye thereon: Mrs. Gardner and Mr. Jarrett.

Approval of Payroll

Mrs. Gardner motioned to approve payroll checks #15456 thru #15505 in the amount of \$48,633.19 with a total of \$4,649.24 going to deferred compensation deductions, etc. Mr. Jarrett seconded the motion. Voting aye thereon: Mrs. Gardner and Mr. Jarrett.

Approval of Minutes

Mrs. Gardner tabled the minutes until Mr. Todd is present.

DEPARTMENT REPORTS

Zoning Department

Linda DeHoff reported that for the month of October 2011, 21 permits were issued as follows:

Total value of permits issued of \$1,342,000.00 total fees collected \$4,063.14. There was \$2,500.00 returned in security deposit fees.

Police Department

Chief Arbogast reported that for the month of October 2011, the department responded to 742 calls for service (see attached). There were 16 thefts and approximately 40 catalytic converters stolen off cars at Bill Doraty-KIA. Hospice of Medina is holding a fund raiser on Thanksgiving Day at Yours Truly. The Chief will be a server.

DEPARTMENT REPORTS CON'T

Fire Department

There was no fire report.

Service Department

Denny Miller, Road Foreman, reported that for the month of October 2011, the department had Remsen Road paved from Route 3 to Frantz Road and 185 feet of Foskett Road; serviced trucks for winter; rebuilt broken barricades; bermed roads; set traffic trailer in several areas of township; planted grass along roadside where concrete was replaced; fixed lights around township buildings; fixed sink hole along Thomas Lincoln Parkway and trimmed trees along roads in developments.

Mrs. Gardner motioned to accept the reports as presented. Mr. Jarrett seconded the motion. Voting aye thereon: Mrs. Gardner and Mr. Jarrett.

Old Business Tabled Items

Mrs. Gardner tabled the following items until all Trustees are present: LST Contract, Comprehensive Plan, Resolution Supporting the Medina County Natural Hazard Mitigation Plan and Lawn Maintenance.

Resignation of Terry Dolly, Firefighter

Mrs. Gardner read Terry Dolly's letter of resignation from the Fire Department. Mrs. Gardner motioned to accept Terry Dolly's letter of resignation from the Medina Township Fire Department. Mr. Jarrett seconded the motion. Voting aye thereon: Mrs. Gardner and Mr. Jarrett.

PUBLIC COMMENT

Mrs. Gardner motioned to open the floor for public comment. Mr. Jarrett seconded the motion. Voting aye thereon: Mrs. Gardner and Mr. Jarrett.

Don Beck (5048 Grande Boulevard) asked Chief Arbogast why Hospice was having their fund raiser on Thanksgiving Day. Chief Arbogast was not sure but he felt the concept was to have breakfast and then prepare Thanksgiving dinner.

Robin Gray (4074 Remsen Road) asked if the jewelry robberies were ever solved. Chief Arbogast said no but there are six agencies working together to solve this.

Don Beck (5048 Grande Boulevard) asked what the issue was with the traffic light on Grande Boulevard and was told that Zaremba installed the light but the Township was maintaining it. It costs the township \$130.00 each time a bulb is changed. Zaremba was asked to take over maintenance of the light and they agreed.

Mrs. Gardner motioned to close the floor for public comment. Mr. Jarrett seconded the motion. Voting aye thereon: Mrs. Gardner and Mr. Jarrett.

OLD BUSINESS

Traffic Light on Grande Boulevard

Denny Miller, Road Foreman, explained that Zaremba Group installed the traffic light on Grande Boulevard but the Township ended up paying to maintain the light. Mr. Miller contacted Zaremba Group and they agreed to take over maintenance of the light.

Police Test

Chief Arbogast said an entry level police test was given to 106 applicants. Of the 106 that took the test only 51 passed the test. He has narrowed it down to 23 candidates. Half of them have Bachelors and Associates Degrees. 4 have Masters Degrees and two have Law Degrees. He has started the background checks and the assessment tests will be the next step.

Shop with a Cop

Chief Arbogast said they will be taking the children shopping on December 10. They will take them to Wal-Mart with lights and sirens. He said they took 31 children from Medina County. They take the children to breakfast and then bring them back for lunch and it costs at least \$4000.00 to provide the food. He said it is a heartwarming experience. Mr. Jarrett said he will chaperone again this year. Mrs. Gardner will also assist.

Ten-minute Recess

Mrs. Gardner motioned to take a 10 minute recess at 7:50 pm. Mr. Jarrett seconded the motion. Voting aye thereon: Mrs. Gardner and Mr. Jarrett. Mrs. Gardner reconvened the meeting at 8:01 pm.

DEPARTMENT PURCHASE ORDERS AND TRAINING REUESTS

Pre-Construction Conference for Pierce Fire Truck

Mrs. Gardner motioned for an appropriation in the amount of \$1,000.00 for a Pre-Construction Conference for engine 201-3 in Appleton, Wisconsin on November 21. This will provide the final direction and approval prior to the manufacture of the fire truck that was just purchased. There will be 4 people from that committee going out there. Pierce is paying for the hotels and some of the meals. They researched whether it would be cheaper to fly or to drive and they found it was cheaper to fly. Mr. Jarrett seconded the motion. Mr. Jarrett asked what four were going and was told it would be Denny Miller, Parker Browne, Brian Mummert and Shawn Kasson. Voting aye thereon: Mrs. Gardner and Mr. Jarrett.

Ohio Turfgrass Foundation Conference

Mrs. Gardner motioned for the appropriation in the amount of \$500.00 for the Ohio Turfgrass Foundation Conference and Show at the Greater Columbus Convention Center on December 6 and 7. It is for the pesticide application license recertification credits and this is for Jeff Kessler. Mr. Jarrett seconded the motion. Mr. Jarrett asked if this was to keep his license updated and was told yes. Voting aye thereon: Mrs. Gardner and Mr. Jarrett.

Total Performance - Service and Repairs of R&B Trucks

Mrs. Gardner motioned for a purchase order to Total Performance in Brunswick, Ohio. It's for repairs and service of trucks 1, 2, 11, 14 and 15 in order to get them ready for the winter season for \$4,500.00. Mr. Jarrett seconded the motion. Mr. Jarrett asked what trucks they were and was told they were the plow trucks. Voting aye thereon: Mrs. Gardner and Mr. Jarrett.

Authorization for Fiscal Officer to Prepare Accounts Payable for November 24, 2011

Mrs. Gardner motioned to authorize the Fiscal Officer to prepare accounts payable checks for the regular meeting dated November 24, 2011, because of the Thanksgiving Holiday and Mr. Jarrett will be out of town. The Township Board of Trustees will allow the Fiscal Officer to print those checks and the Trustees will then sign the checks and approve the checks by vote at the December 8, 2011, meeting.
