

**RECORD OF PROCEEDINGS
MINUTES OF REGULAR MEETING
APRIL 5TH, 2007**

The Medina Township Board of Trustees met in regular session at the Medina Township Hall on April 5th, 2007, to conduct the business of the Township. President Todd called the meeting to order at 7:00 pm with the following Trustees in attendance: Dianna Huffman, Michael D. Todd and Mead Wilkins. Also in attendance were the Police Chief, Fire Chief, Road Foreman, Zoning Inspector, Assistant County Prosecutor, William Thorne and the general public.

ROLL CALL

Mr. Todd asked for a roll call of all members present. Trustees present were Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Mr. Todd led the Pledge of Allegiance.

SITE PLANS

Dirty Cowboys – Sign – 2743 Medina Road (Plaza 71)

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the wall sign for Dirty Cowboy's not to exceed 80 square feet as submitted. Mrs. Huffman seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Rick Roush Motor Sports – Wall Sign – 3147 Eastpointe Dr.

Mr. Todd motioned to accept the recommendation of the Zoning Commission and deny the request for a third wall sign for Rick Roush Motor Sports as it does not comply with the Medina Township Zoning Resolution Section 605 I.1. Wall Signs. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Medina World Cars VW–Ground Sign – 3950 Pearl Rd.

Mr. Todd motioned to accept the recommendation of the Zoning Commission and deny the request of the ground sign for Medina World Cars VW, due to failure to meet the height requirement for a ground sign per the Medina Township Zoning Resolution Section 605 H. Ground Signs. Mrs. Huffman seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Lifetime Family Chiropractic –Wall Sign – 3848 Medina Rd.

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the wall sign for Lifetime Family Chiropractic not to exceed 24 square feet as submitted. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

State of Ohio Highway Patrol – Site – 3149 Frantz Rd.

Mr. Todd motioned to accept the recommendation of the Zoning Commission and deny the site plan request for construction of a new facility to accommodate the State of Ohio Highway Patrol located at 3149 Frantz based on the following non-compliance of the Medina Township Zoning Resolution:

Section 401.3D-Building Front Yard Setback-Frantz Rd. The site plan shows 75 feet. The requirement is 100 feet. Therefore a 25 foot variance is required.

Section 401.3D-Building Front Yard Setback-Weymouth Rd. The site plan shows 31 feet 7 inches. The requirement is 100 feet. Therefore a 68 foot 5 inch variance is required.

Section 401.3E-Building Side Yard Setback on the site plan shows 14 feet 6 inches. The requirement is 25 feet. Therefore a 10 foot 6 inch variance is required.

SITE PLANS CON'T

State of Ohio Highway Patrol-Site – 3149 Frantz Rd. Con't

Section 401.3E for the Side Yard Setback for the antenna as well as Section 303 E.2 for the height of the antenna. The site plan shows the height of the antenna at 58 feet. The requirement is 50 feet. Therefore an 8 foot variance is required.

Section 306J.3 (a)-Landscape Depth (Front Yard)-Frantz Rd. and Weymouth Rd. The site plan shows 2 feet. The requirement is 20 feet for both roads. Therefore an 18 foot variance is required.

Section 306J.3 (a)-Landscape Depth Front Yard on Frantz/Weymouth Rd. The site plan shows 2 feet. The requirement is 20 feet. Therefore an 18 foot variance is required.

Section 306J. (c) Landscape Depth Side Yard. The site plan shows 14 feet 6 inches. The requirement is 15 feet. Therefore a 6 inch variance is required.

The generator and dumpster are both proposed to be located in the setback and would require variances as well.

Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

State of Ohio Highway Patrol – Sign – 3149 Frantz Rd.

Mr. Todd motioned to accept the recommendation of the Zoning Commission and deny the ground sign request for the State of Ohio Highway Patrol as it does not meet the zoning regulations per Section 605 H. of the Medina Township Zoning Resolution requiring a ground sign to be a minimum of 10 feet back from the road right-of-way as presented. Mrs. Huffman seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Waterford Office Park Building D – Site – 3960 Medina Rd.

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the site plan for Building D to be located in the Waterford Office Park as presented. Mrs. Huffman seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Advantage Design Studios – Sign – 4081 N. Jefferson St.

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the wall sign for Advantage Design Services, Inc. not to exceed 3.6 square feet as presented as well as the face panel in the existing ground sign not to exceed 3.1 square feet as presented. Because the signage was erected prior to obtaining a zoning permit the fee will be doubled. Mrs. Huffman seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Executive Session

Mr. Todd motioned to enter into Executive Session with the Board of Trustees and Township Legal Counsel to discuss legal matters relative to the transfer of property. The Board entered into Executive Session at 7:23 pm. The Board reconvened at 8:40 pm. No decisions were made at that time.

Mr. Todd motioned to open the floor for public comment. Mr. Wilkins seconded the motion.

Kerry Illes (3599 Reserve Commons Dr.) regarding the access road for Blakslee Park.

PUBLIC COMMENT CONT

Rebecca Benbella of the Medina County Auditors Office said old appliances will be collected at Westfield Center the week of April 9 and Mr. Kovack has been appointed to the Community Improvement Board.

Bob Armbruster (3565 Huffman Rd.) commented on the access road for Blakslee Park.

Mr. Todd motioned to close the floor for public comment. Mr. Wilkins seconded the motion.

Approval of Payroll

Mr. Todd motioned to approve payroll checks number 11033 to 11077 totaling \$27,957.16 with \$2,891.59 being deducted for OPERS, Deferred Compensation and union dues. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Mr. Todd motioned to approve payroll checks number 11078 to 11081 totaling \$2,915.54 with \$515.01 being deducted for OPERS and other deductions. Mrs. Huffman seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

REPORTS

Fire Department

There was no fire report.

Road Department

Denny Miller reported that for the month of March 2007, the Road Department cleaned and maintained buildings, equipment and vehicles; repaired and replaced signs as needed; plowed and salted roads; fixed lights around the Township complex; attended seminar at Medina Tractor.

Police Department

Chief Arbogast said CPR and First Aid training is in progress. Sgt. Zieja will be attending leadership training. All officers have trained with the Firearms Simulator. The Chief reported that for the month of March 2007, the Police Department responded to 1,040 calls for serviced. 364 community policing, 592 traffic related calls and 62 alarm drops. There were 42 arrests made, 33 were drug and alcohol related. Chief Arbogast continues to work on the litter control program, DUI enforcement with the Ohio State Patrol on Rte 71, a neighborhood watch program and business crime reduction on 18 and 42.

Zoning Department

Elaine Ridgley reported that for the month of March 2007, 21 zoning permits were issued as follows:

Mr. Todd read the letter from ODOT regarding their review of the traffic signal function at Fenn Road and Route 42 and the storage lane for entrance and exit to Streetside Café and Skateland on Route 42 (see attached).

Ambulance Service/Emergency Medical Services Levy

Resolution Declaring it Necessary to Levy a Tax in Excess of the Ten Mill Limitation

Resolution No. 04052007-010

Mr. Todd moved the adoption of the following Resolution:

WHEREAS, the amount of taxes which May be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of said Medina Township, Medina County, Ohio; therefore be it

RESOLVED, by the Board of Trustees of the Township of Medina, Medina County, Ohio, two-thirds of all members elected thereto concurring, that it is necessary to levy a tax in excess of the ten mill limitation for the benefit of Medina Township for the purpose of providing ambulance service/emergency medical services or both at a rate not exceeding 1 (one) mill for each one dollar of valuation, which amounts to 10 (ten) cents for each one hundred dollars of valuation for 5 (five) years, an additional tax.

RESOLVED, that the question of levying additional taxes be submitted to the electors of said Medina Township at the special election to be held at the usual voting places within said Medina Township on the 7th day August, 2007, and be it further

RESOLVED, that said levy be placed upon the tax list of the current year next succeeding the election, if the majority of the electors voting thereon vote in favor thereof; and be it further

RESOLVED, THAT THE Fiscal Officer of this Board of Trustees be and she is hereby directed to certify a copy of this Resolution to the Board of Elections, Medina County, Ohio, and notify said Board of Elections to cause notice of election on the question of levying said tax to be given as required by law.

Mr. Wilkins seconded the motion and the roll being called upon its adoption the vote resulted as follows: Mrs. Huffman, aye

The Board entered into Executive Session at 9:16 pm. The Board reconvened at 9:52 pm. No decisions were made at this time.

Mr. Todd reconvened the meeting at 9:53 pm. All Trustees and members of the general public were still in attendance.






Re: MED. US 42 and Fenn Road

Dear Mr. Todd:

This is in response to your inquiry regarding the extension of the southbound left turn storage lane on US 42 and a request to review the left turn phase operation for Fenn Road. I apologize for the delay in responding.

In regard to the left turn phase, based upon the information contained in your inquiry, local residents had experienced situations when the left turn phase would not activate. Our traffic signal electricians have reviewed the signal operation and equipment to ensure the signal is functioning properly. The results of their investigation indicated the left turn phase is operating as it was designed. We can only speculate that the motorists who have had this experience may have stopped or moved beyond the stop bar where the loop detector for the left turn phase is located. This detector monitors the presence of vehicles in the left turn lane and then relays that information to the traffic signal controller. To address this situation, we have installed an additional loop detector which is located beyond the stop location to ensure detection of any vehicle which may pull into the intersection to perform the turn maneuver. The additional detector should alleviate the problem.

The other concern noted in your correspondence involved vehicles turning left from US 42 into the Skateland or Streetside Café establishments. It is our understanding that the request is to extend the existing left turn lane for southbound US 42 to accommodate traffic accessing the local businesses. Extending the left turn lane and utilizing a portion of the lane designated as storage for Fenn Road traffic could result in a condition where vehicles wishing to turn onto Fenn Road would be impeded and in direct conflict with vehicles turning into the businesses. Even though the current situation is not ideal, hopefully you can understand our concerns.

Again, thank you for taking the time to contact us and share your concerns. We want to encourage you to contact us with any future operational and safety issues which come to your attention or that you may experience on the state highways system. We value your input.
