# RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING MARCH 20<sup>TH</sup>, 2008

Also in attendance were the Fiscal Officer, Fire Chief, Road Foreman, Assistant Road Foreman, Assistant Zoning Inspector and the general public. The Police Chief arrived later.

## Roll Call

#### Scenic Byway

#### Hometown Heroes Memorial

Mr. Wilkins met with the Officials from the Career Center regarding having the students help with the laying of the paver stones for the Hometown Heroes War Memorial. He showed them the site plan and the Officials were very receptive to the idea and will review the project.

#### Lake Medina

Mr. Wilkins said he spoke with Mayor Leaver and asked if the Township could have Lake Medina back. Lake Medina has a 99 year lease to the park district and if the City breaks the lease they are responsible for the improvements which are about \$250,000.00 at this point with the bridge and the parking off of Granger Road. Mayor Leaver will discuss this with City Council about a transfer.

Mr. Wilkins also spoke with Tom James of the Park District about possibly doing the same thing with the Simon Property.

#### Armbruster Tree Line

Mr. Wilkins had Don Grace look at the tree line of the Armbruster property next to the Townhall Complex. Some of the trees have died and need to be replaced per a Gentleman's Agreement years ago. Mr. Grace will inform Mr. Armbruster and the Trustees of how the trees can be replaced.

#### Blakslee Landscaping

Mr. Wilkins had Don Grace of Grace Brothers Landscaping draw up a plan for landscaping for Blakslee Park. Mr. Grace gave copies of his design plan to the Trustees to review. Mr. Wilkins will continue to oversee this project.

# Fire Department Travel Expenses/Equipment

Mrs. Holt motioned to approve the following Fire Department Travel Expenses:

## Fire District Meeting/LST Meeting

Mrs. Holt said a meeting is being set up to discuss the Fire District. Chief Crumley is trying to coordinate a meeting between Medina Township, Montville Township, York Township, Medina City and two firms to do a cost study for a Fire District. Mr. Wilkins also said the LST meeting has not been rescheduled because there is disagreement as to whether this meeting is subject to open meeting provisions. Chief Crumley said it has gone to the Ohio Attorney General Off ice for an opinion.

#### Executive Session

Mr. Todd motioned to enter into Executive Session with the Medina Township Board of Trustees, Fiscal Officer and Assistant County Prosecutor, William Thorne, to discuss purchase of property and sale of property for Medina Township. Mrs. Holt seconded the motion. Voting aye thereon: Mrs. Holt, Mr. Todd and Mr. Wilkins. The Board entered into Executive Session at 7:25 pm. The Board reconvened at 8:17 pm. No decisions were made at that time.
