## OLD BUSINESS

#### Full-time Road Department Comp Time

The Trustees discussed comp time for the Road Department. Mr. Wilkins is going to modify the proposal and make the adjustments. It will be presented at the next meeting. The Uniform allowance will be included in the budget.

#### AT&T Property-3833 Weymouth Road

Mr. Wilkins said the Township had a quit claim deed since 1979 for the property at 3833 Weymouth Road which the Township had maintained and paid taxes on. The current Trustees and Mrs. George found that the Township should not have been paying taxes and that the property technically was no longer the townships due to a clause stating a fire station had to be built within 2 years or the property would revert back to AT&T. Mrs. George was able to get a refund of approximately \$30,000.00 on the taxes paid. AT&T was asked to deed the property to the Township because the Township maintained it for all those years. The AT&T Representative discussed the issue with their lawyer and was told that since a fire station was not built on the land it reverts back to them and they want it back. Mr. Wilkins said to inform AT&T that the Township will no longer be mowing the property.

#### **Training Policy**

Mrs. Holt has given the other Trustees a draft copy of the Training Policy for their review.

#### Job Descriptions

Mr. Wilkins said Job Descriptions are being worked on.

#### Noise Resolution

Mr. Wilkins said Mr. Thorne, Asst. County Prosecutor, will be attending the March 4, 2009, Trustees meeting to discuss this issue.

## **Cook Road Damages**

Mr. Todd said the Cook Road damages request is being handled by the Prosecutor.

## Police Section of the Record Retention Policy

Chief Arbogast is to meet with Dean Holman, Medina County Prosecutor, to review this section.

### **Special Event Permit**

Mrs. Holt said there is a Special Event Permit section in the Zoning Book. The Trustees are looking into a less restrictive policy for businesses to adhere to.

#### Siman Park

Mr. Wilkins said Siman Park is part of the Conservation Easement and therefore is finished.

Chief Crumley said Mr. Thorne is also putting together a letter regarding LST response.

#### Road Salt 2009/2010 Season-Resolution

## Resolution No. 02192009-012

Mr. Wilkins motioned to put forth the following resolution authorizing participation in the ODOT Cooperative Purchasing Program by reference.

WHEREAS, Section 5513.01 (B) provides the opportunity for Counties, Townships, Municipal Corporations, Conservancy Districts, Township Park Districts, Park Districts created under Chapter 1545 of the Revised Code, Port Authorities, Regional Transit Authorities, Regional Airport Authorities, Regional Water and Sewer Districts, County Transit Boards, State Universities or Colleges to participate in contracts of the Ohio Department of Transportation for the purchase of machinery, material, supplies or other articles.

NOW, THEREFORE, Be it ordained by Medina Township;

SECTION 1. That Denny Miller hereby requests authority in the name of Medina Township to participate in the Ohio Department of Transportation contracts for the purchase of machinery, materials, supplies or other articles which the Department has entered into pursuant to Ohio Revised Code Section 5513.01 (B).

SECTION 2. That Denny Miller is hereby authorized to agree in the name of Medina Township to be bound by all terms and conditions as the Director of Transportation prescribes.

SECTION 3. That Denny Miller is hereby authorized to agree in the name of Medina Township to directly pay vendors, under each such contract of the Ohio Department of Transportation in which Medina Township participates, for items it receives pursuant to the contract.

SECTION 4. That Medina Township agrees to be responsible for resolving all claims and disputes arising out of its participation in the cooperative purchasing program under Section 5513.01 (B) of the Ohio Revised Code. Medina Township releases and forever discharges the Director of Transportation and the Ohio Department of Transportation from all such claims, actions, expenses or other damages arising out of its participation in the cooperative purchasing program which Medina Township may have or claim to have against ODOT or its employees, unless such liability is the result of negligence on the part of ODOT or its employees.

Mrs. Holt seconded the motion. Voting aye thereon: Mr. Wilkins, Mrs. Holt and Mr. Todd.

Mr. Wilkins motioned to request bids for the lawn maintenance 2009/2010 season with advertising being on February 24, 2009, and March 4, 2009, with a mandatory pre-bid meeting on March 12, 2009, at 10:00 am at 3718 Weymouth Road with a bid opening date of March 19, 2009, at 6:30 pm. Mr. Todd seconded the motion. Voting aye thereon: Mr. Wilkins, Mr. Todd and Mrs. Holt.

#### Project Application Form for New Safety Services Complex

Mr. Todd said he spoke with Parker Browne of the Fire Department regarding a new Fire/Police Safety Services Complex. The first phase would be a feasibility study and land acquisition. Phase 2 would be if they could find land and if the feasibility study states that it is in the best interest of the Township. Grant money will be applied for to do a feasibility study and fund the safety service complex.

## Resolution No. 02192009-013

Mr. Todd motioned to put forth the following resolution to put in for an appropriation to request for fiscal year 2010, for the development and potential construction of a Fire Department and a Police Department Complex. Mr. Wilkins seconded the motion. Voting aye thereon: Mr. Todd, Mr. Wilkins and Mrs. Holt.

### **Blakslee Park Opening**

Mr. Wilkins said the Blakslee Park Opening will be June 7, 2009. Private donations will be asked for. More information will be forthcoming. Mr. Wilkins motioned to approve up to \$2,000.00 for the grand opening of Blakslee Park. Mrs. Holt seconded the motion. Voting aye thereon: Mr. Wilkins, Mrs. Holt and Mr. Todd.

### Pitney Bowes Contract

Mr. Wilkins motioned to approve a 36 month contract with Pitney Bowes (for postal meter) for \$46.00 per month. Mr. Todd seconded the motion. Voting aye thereon: Mr. Wilkins, Mr. Todd and Mrs. Holt.

Mr. Wilkins motioned to open the floor for public comment. Mrs. Holt seconded the motion. Voting aye thereon: Mr. Wilkins, Mrs. Holt and Mr. Todd.

Mrs. Holt motioned to approve an additional expenditure of \$988.55 for Finley Fire and \$200.00 for Dalmatian Fire. Mr. Todd seconded the motion. Voting aye thereon: Mrs. Holt, Mr. Todd and Mr. Wilkins.

#### Automatic Defibrillator for Police Department

Mr. Todd motioned to amend the original purchase order to approve the amount of \$2,184.00 which is an increase of \$119.00 from the original purchase order for the purchase of the AED. Mrs. Holt seconded the motion. Voting aye thereon: Mr. Todd, Mrs. Holt and Mr. Wilkins.

### Executive Session

Mr. Todd motioned to enter into Executive Session with the Board of Trustees and the Fiscal Officer to discuss employees, employee compensation and potential land acquisition for the township. Mrs. Holt seconded the motion. Voting aye thereon: Mr. Todd, Mrs. Holt and Mr. Wilkins. The Board entered into Executive Session at 9:08 pm. The Board reconvened at 9:39 pm. No decisions were made during that meeting.

### **Chief Arbogast Overtime**

Mr. Todd said the Trustees do not want Chief Arbogast to work any overtime unless it is for a special event or a holiday. Mr. Todd motioned to approve the 4 hours, that are currently pending, of overtime for Chief Arbogast and approve that expenditure as he did work that time with the clarification that 80 hours is maximum (per pay period) absent holidays and special days for the Township. Mrs. Holt seconded the motion. Voting aye thereon: Mr. Todd, Mrs. Holt and Mr. Wilkins.

## Hiring Information Officer Full-time

Mr. Todd motioned to adjust the Information Officer from currently a part-time position to a fulltime position for the Township and be sure it fits within the budget. Mrs. Holt seconded the motion. Voting aye thereon: Mr. Todd, Mrs. Holt and Mr. Wilkins.

## Two (2) Grant Writers Position

Mr. Wilkins motioned to amend the organizational plan to have the two (2) grant writer positions not to exceed 1,499 hours per person per calendar year. Mrs. Holt seconded the motion. Roll call vote: Mr. Wilkins aye, Mrs. Holt aye and Mr. Todd abstain.

Mr. Todd motioned to amend the Organizational Minutes to terminate the deadline for terminating the grant writers' position and to just get rid of completely creating a full-time position as a grant writer for the township. Mrs. Holt seconded the motion. Voting aye thereon: Mr. Todd, Mrs. Holt and Mr. Wilkins.

#### Trustee Meeting Time

Mr. Todd motioned to amend the Organizational Minutes to change the Meeting time from 6:30 pm to 7:00 pm effective March 5, 2009. Mr. Wilkins seconded the motion. Voting aye thereon: Mr. Todd, Mr. Wilkins and Mrs. Holt.

Mr. Todd said he met in Akron with Parker Browne to discuss the Project Application Form for the Safety Services Building and said it was very informative meeting.

Mr. Wilkins motioned to adjourn the meeting. Mr. Todd seconded the motion. Voting aye thereon: Mr. Wilkins, Mr. Todd and Mrs. Holt.
