## RECORD OF PROCEEDINGS MINUTES OF REGULAR MEETING APRIL 16th, 2009

The Medina Township Board of Trustees met in regular session at the Medina Township Hall on April 16<sup>th</sup>, 2009, to conduct the business of the Township. President Wilkins called the meeting to order at 6:35 pm with the following Trustees in attendance: Rita M. Holt, Michael D. Todd and Mead Wilkins. Also in attendance were the Fiscal Officer, Police Chief, Fire Chief, Road Foreman, Assistant Road Foreman, Sports Fields Director, Zoning Inspector and the general public.

Mr. Wilkins led the Pledge of Allegiance.

## Roll Call

Mr. Wilkins asked for a roll call of all members present. Trustees present were Mrs. Holt, Mr. Todd and Mr. Wilkins.

Mrs. Holt stated that to date, the cost for Blakslee Park was \$2,210,160.22 (this includes the maintenance building).

Mr. Wilkins motioned to adjourn the meeting. Mrs. Holt seconded the motion. Voting aye thereon: Mr. Wilkins, Mrs. Holt and Mr. Todd.
