Mr. Todd asked for a roll call of all members present. Trustees present were Mr. Todd and Mr. Stopa. Mr. Wilkins was absent.

Mr. Todd led the Pledge of Allegiance.

SITE PLANS

Jones Fish Hatcheries – Site – 5010 Gateway Drive

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the use for Jones Fish Hatcheries & Distributors, Inc. to be located at 5010 Gateway Drive Unit A-1 as presented. Mr. Stopa seconded the motion. Voting aye thereon: Mr. Todd and Mr. Stopa.

Jones Fish Hatcheries - Sign - 5010 Gateway Drive

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve a tenant panel sign for Jones Fish Hatcheries Distributors, Inc. to be located at 5010 Gateway Drive Unit A-1 not to exceed 5.29 square feet as presented. - 2. Section 503.A.2. Parking- 3 spaces/dwelling unit required. Request reduction to 1.5 parking spaces per dwelling unit;
- 3. Section 406.3.D.2. (a) 1. Commercial Sideyard Setback abutting residential 75 feet required, 30 feet requested on western boundary line;
- 4. Section 308F.4 (a) Overall Density 30 units permitted 34 units proposed; Density per Acre 6 units per acre permitted, 7.3 units per acre proposed on new parcel "D". Mr. Stopa seconded the motion. Voting aye thereon: Mr. Todd and Mr. Stopa.
