President Todd called the meeting to order at 7:32pm with the following Trustees in attendance: Dianna Huffman, Michael D. Todd and Mead Wilkins. Also in attendance were the Acting Fiscal Officer, Fire Chief, Police Chief and the general public.

#### Roll Call

Mr. Todd asked for a roll call of all members present: Trustees present were Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Mr. Todd led the Pledge of Allegiance.

Mr. Todd motioned to open the floor to public comment. Mr. Wilkins seconded the motion.
