

**RECORD OF PROCEEDINGS  
MINUTES OF SPECIAL MEETING  
NOVEMBER 30<sup>th</sup>, 2006**

The Medina Township Board of Trustees met in special session at the Medina Township Hall on November 16<sup>th</sup>, 2006, to conduct the business of the Township. President Todd called the meeting to order at 7:31 pm with the following Trustees in attendance: Dianna Huffman, Michael D. Todd and Mead Wilkins. Also in attendance were the Fiscal Officer, Fire Chief, Police Chief and the general public.

**Roll Call**

Mr. Todd asked for a roll call of all members present: Trustees present were Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Mr. Todd led the Pledge of Allegiance.

**PUBLIC COMMENT**

Mrs. Huffman motioned to open the floor for public comment. Mr. Wilkins seconded the motion.

There were no public comments.

**NEW BUSINESS**

**Oath of Office for Michael Oyler – Police Officer**

Mr. Todd motioned to hire Michael Oyler as our new Medina Township Police Officer. Mrs. Huffman seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins. Mr. Todd then administered the oath of office to Michael Oyler.

**Medina City Dispatch Contract**

**Route 42 Widening & Sidewalks**

Mr. Wilkins, Trustee, said there is an illegal sign at TSC.

Chief Arbogast discussed the improvements to the web page, DNA kits for children and a security alert program.

Mr. Todd motioned to close the floor for public comment. Mr. Wilkins seconded the motion.


**Cutting Jefferson Street Through to Fenn Road**
