The Hoffman Group - Identification Sign - 5000 Foote Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the identification sign for the complex not to exceed 72 square feet as presented. Mr. Wilkins seconded the motion.

Mr. Todd motioned to table the vote on the identification sign located at 5000 Foote Road for The Hoffman Group. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Westfield Bank - Sign - 4992 Foote Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and deny the two portico signs for Westfield Bank as they are not in compliance with the Zoning Resolution per Section 605 I.1. Wall Signs, in that only one wall sign is permitted. Mr. Wilkins seconded the motion.

Mr. Todd motioned to table the vote for the sign located at Foote Road for Westfield Bank. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Critchfield, Critchfield & Johnston - Sign - 4996 Foote Road

Wall Signs, in that only one wall sign per business is permitted. Mr. Wilkins seconded the motion.

Mr. Todd motioned to table the vote for the sign located at 4996 Foote Road for Critchfield, Critchfield & Johnston. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

River Trace Subdivision Phase II - Site Remsen Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the revised preliminary plan for Phase II River Trace Subdivision. It was so noted that some lots would require careful empirical data that a home could fit within the building envelope on the lot. Mrs. Huffman seconded the motion. John Montali - Lot Split - 3594 Pearl Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and deny the request for site plan approval for a proposed building to be located at 3594 Pearl Road due to the fact that the frontage and side yard requirement for this lot do not meet the zoning code requirements. Mr. Wilkins seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Waterford Properties Office Park - Revised Site - 3960 Medina Road

Mr. Todd motioned to accept the recommendation of the Zoning Commission and approve the revised site plan for Waterford Properties Office Park notating that the sanitary sewer under building D is no longer applicable and is being removed. Mrs. Huffman seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Appointment of Jason Watts as Medina Township Police Officer

Mr. Wilkins motioned to hire Jason Watts as a Police Officer for Medina Township pursuant to the union agreement. Mrs. Huffman seconded the motion. Voting aye thereon: Mrs. Huffman, Mr. Todd and Mr. Wilkins.

Mr. Watts will be filling the position left vacant by Brian Kozel.
