

**RECORD OF PROCEEDINGS
MINUTES OF SPECIAL MEETING
SEPTEMBER 7TH, 2006**

The Medina Township Board of Trustees met in special session at the Medina Township Hall on September 7th, 2006, to conduct the business of the Township. Vice-President Huffman called the meeting to order at 7:35 pm with the following Trustees in attendance: Dianna Huffman and Mead Wilkins. Also in attendance were the Police Chief and the general public.

Roll Call

Mrs. Huffman asked for a roll call of all members present. Trustees present were Mrs. Huffman and Mr. Wilkins. Mr. Todd was absent.

Mrs. Huffman led the Pledge of Allegiance.

PUBLIC COMMENT

Mrs. Huffman motioned to open the floor for public comment. Mr. Wilkins seconded the motion.

Doug Eastwood of Medina Excavating gave Trustees an update regarding Blakslee Park.
